#### **SUMMARY**

Performs basic laborer duties such as digging, lifting and cleaning TOUA grounds. Assists line crews to construct and repair electric lines and equipment by performing the following duties.

## ESSENTIAL DUTIES AND RESPONSIBILITIES include the following.

- Performs duties that pertain to worksite preparation such as cleaning, clearing, tree trimming and digging.
- Gather tools and supplies to be used at work site.
- Measures, cuts, bends wire and conduit, and assists line crews when framing poles.
- Drills holes and pulls wire.
- Assists in lifting, positioning, and fastening objects such as cross-arms, transformers, wire, conduit, and other electric equipment.
- Maintains tools and equipment and keeps supplies and parts in order.
- Cleans work area, machines, tools and equipment. Performs other routine duties.
- Drives vehicle that do not require a CDL.
- Attends and participates in safety meetings to become aware of safety rules and regulations and to help assure that safe working practices are followed and a safe working environment exists for the individual, fellow employees and customers
- Other duties may be assigned.
