Do I need to take special precautions?

Some people may be more vulnerable to contaminants in drinking water than the general population. Immunocompromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. Your water comes from 2 ground water sources.

Why are there contaminants in my drinking water?

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity including:

microbial contaminants, such as viruses and bacteria, that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife; inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban stormwater runoff, industrial, or domestic wastewater discharges, oil and gas production, mining, or farming; pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses; organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems; and radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Additional Information for Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. PWS system is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Per- and Polyfluoroalkyl Substances (PFAS) Monitoring

Last year, your water system participated in a voluntary sampling project that evaluated for the presence of twenty-five PFAS compounds. No PFAS constituents were detected in your drinking water.

PFAS are a group of thousands of synthetic chemicals that have been in use since the 1940s. PFAS have been found in a wide array of consumer and industrial products and as an ingredient in firefighting foam. Current scientific research has shown links between exposure to some PFAS chemicals and adverse health outcomes. Drinking water may be impacted in communities where these chemicals have contaminated the water supply. EPA does not currently regulate any PFAS compounds, but has established health advisories for two PFAS compounds, and is currently working to develop a National Drinking Water Regulation for PFAS. EPA anticipates finalizing the rule in fall of 2023.

We are required to test your water regularly for signs of microbial contamination. Positive test results could lead to follow-up investigations called assessments and potentially the issuance of public health advisories. Assessments could lead to required corrective actions. Significant Deficiencies

Sanitary deficiencies are defects in a water system's infrastructure, design, operation, maintenance, or management that cause, or may cause interruptions to the "multiple barrier" protection system and adversely affect the system's ability to produce safe and reliable drinking water in adequate quantities.

The following is a listing of significant deficiencies that have yet to be corrected. Your public water system is still working to correct these deficiencies and interim milestones are shown, as applicable.

Deficiency Title: Distribution System Pressure

Date Identified: 6/10/2021 Overall Due Date: 12/31/2023

Deficiency Description: As stated in previous sanitary surveys, there are homes near the storage tank and Well 3 that would not have a minimum distribution system pressure of 20 psi, based on the elevations of the homes in relation to the elevation and depth of Storage Tank 1. Pressures were not obtained from the closest homes, but the elevation difference between the closest home and Storage Tank 1 is approximately 16 feet. With the 29-foot-tall storage tank, the static pressure provided at the closest home would be approximately 16 psi if the tank was ³/₄-full.

Corrective Action Plan: Low water pressure increases the risk of backflow contamination into the distribution system. Most modern design standards (e.g., Ten States Standards) recommend a minimum working pressure of 35 psi under normal conditions and 20 psi during extreme conditions, such as fire flows. Methods of increasing pressure to the upper elevations in the distribution system for New Fields PWS should be investigated. It is understood that the New Fields PWS is presently under design to be tied in with the Topawa Intertie PWS and that keeping the New Fields PWS storage tank operational is being considered in the design. It is recommended that low pressure in the New Fields PWS distribution system be considered in the design of the intertie. TOUA should also consult with a professional engineer to evaluate, and provide recommendations for, interim solutions to increase pressure within the distribution system. To the extent that interim solutions are feasible, those solutions should be implemented.
